Registration and payment for a clinic, private instruction, cattle practice, or other event at Barnes Ranch incorporates the participant's understanding and agreement to the Release of Liability on the registration form and agreement to the *Facility Use & Rules*. Please clarify any information you do not understand with the Facility Manager.

Release: Inherent risks of animal activities including horse and cattle activities include running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on that may result in an injury, harm, or death to persons and horses on or around them.

Animals can react unpredictably to such things as sound; sudden movements; unfamiliar objects, persons, or other animals; certain hazards such as surface or subsurface conditions; and collisions with other animals or objects. These unpredictable reactions also may result in injury, harm, or death to persons or horses on or around them.

Under the Colorado Equine Act, Colorado Revised Statute, Section 13-21-119 and related sections, each participant who engages in an equine activity or equine-related activity such as seminars, clinics, cattle practices, competitions, riding lessons, or other events and activities held at Barnes Ranch or in conjunction with an event or activity sponsored by Barnes Ranch expressly assumes the risk and legal responsibility for injury, loss, damage, or death to person, horse, or property.

I understand that wearing a riding helmet might prevent injury or death. I understand that Barnes Ranch recommends the use of a riding helmet. If I choose to ride without a riding helmet *it is at my own risk.*

It is suggested that the participant carry appropriate insurances such as personal, trailer, horse, equipment, or other types as needed.

The rider may be held personally liable for the market value cost of an injured/killed cow if it is determined *that the rider caused the injury or death.*

Barnes Ranch discourages the use of alcohol during horse activities. If you choose to drink alcohol while on the premises, you take responsibility for your own safety and will be aware and concerned for the safety of others on the premises and off the premises such as driving your vehicle.

Participant agrees to hold Gerrie and Jeff Barnes, Barnes Ranch, its employees, volunteers, instructors, trainers, clinicians, and associations participating in events and activities, and their heirs and successors harmless from and against any and all claims, actions, damages, liability, and expense in connection with loss of life, personal injury, and/or damage to horses or property arising out of participation in this seminar, clinic, cattle practice, competition, riding lesson or other events or activities *now and in the future.*

The general understanding of the "publication, video, and internet consent and release agreement" is incorporated into this release including: no monetary considerations; photo, video or verbal statements may be used in subsequent years; is given without coercion or duress; and is binding upon heirs and/or future legal representatives.

We are committed to providing a safe facility for participants and visitors. These "Facility Rules" are meant for your safety, the safety of others. Thank you for abiding by them.

- ✓ No Smoking anywhere on this facility.
- ✓ Both visitors and participants *must* sign a **release of liability form**.
- ✓ Children must be attended and supervised at all times.
- ✓ No loose pets.
- ✓ This is a family-friendly environment. No inappropriate language, drugs, or unacceptable behavior will be tolerated. We retain the right and discretion to immediately dismiss anyone from this facility.
- ✓ Put all trash in covered, designated trash containers.

For horse-related events:

- ✓ Wearing a safety helmet when riding is recommended. Wear clothing appropriate for working around horses including proper footwear. We discourage alcohol in conjunction with horse activities for safety reasons.
- ✓ Pick up your horse's manure and deposit in appropriate tubs when possible.
- ✓ Tie your horse to designated hitching posts or to your horse trailer and not to temporary panels, stall doors, or in other locations. The steel, permanent arena rails may be tied to.
- ✓ Your safety, the safety of your horse, and the safety and behavior of person(s) or animal(s) that accompany you are your responsibility.
- ✓ No abusive or inhumane treatment of a horse or inhumane equipment as defined in the AQHA official handbook will be tolerated. We retain the right and discretion to immediately dismiss anyone from this facility.
- ✓ **Please bring any concerns, problems, or suggestions to the facility manager as soon as possible.**

Travel Directions: 13751 E. Cherry Creek Rd. East of I-25 and East of Hwy. 83

From the Denver area: Go to Franktown which is South of Parker or East of Castle Rock. Go South of Franktown on Hwy 83 past Cherry Creek Elementary School to Gillian St. Turn left and go to the "T" which is E. Cherry Creek Rd. Turn right and go past Jones Rd. to the 1st property on your right.

From the Kiowa/Elizabeth area: From Hwy. 86, turn south on CR 17-21. Go past CR 106 to the right-hand-only turn onto CR. 98. Turn right and go until the "T" at E. Cherry Creek Rd. Turn left and go past Jones Rd. to the 1st property on your right,

From the Colorado Springs area: Go North of Colorado Springs on Hwy 83 towards Franktown. Turn right at Palmer Divide Rd. (second flashing light). Follow this road for approximately 8 miles. The last 3 miles will have a series of "S" turns. Be sure to slow WAY down for those turns. Turn left at E. Cherry Creek Rd. Go two miles to our property on the left. If you pass Jones Rd. you have gone too far.

From I-25: Exit #163 (Palmer Lake/County Line Rd.). Go East on County Line Rd. to Hwy. 83. Cross Hwy. 83 and continue straight. The road name changes to Palmer Divide Rd. Follow this road for approximately 8 miles. The last 3 miles will have a series of "S" turns. Be sure to slow WAY down for those turns. Turn left at E. Cherry Creek Rd. Go two miles to our property on the left. If you pass Jones Rd. you have gone too far.
